

AIIB Q1 2020 Report on the Policy of Public Information

This report summarizes the Asian Infrastructure Investment Bank's (AIIB or the Bank) information disclosure practices as required by the <u>Policy on Public Information</u> and its <u>Directive</u> during the period from Jan. 1 to March 31, 2020.

The report contains two parts. Part 1 is about AIIB's practices in proactive disclosure. Part 2 is about AIIB's responses to information requests. Part 3 is about other general information of interest as it relates to information disclosure.





Figure 3. Number of Requests Received by Month, Q1 2020




Figure 4 shows the requests per respective category for Q1 2020. Requests for project information and career opportunities accounted for more than half of the total.

Figure 5. Top 10 Locations of Requesters, Q1 2020




Figure 6 shows the professional background of the requesters. Requesters from academia, consulting and financing composed the top three largest groups.




Figure 6. Requesters' Professional Background, Q1 2020

New Project Pages Launch

On Feb. 8, 2020, AIIB launched the new project pages. The <u>Project Summary</u> Page provides key project data at a glance. The <u>Project List</u> allows more search options including Sector, Financing Type (Cofinanced/Standalone) and Project Type (Sovereign/Nonsovereign). The individual project webpages were also restructured for easier access to project information and client's/co-financier's documents.
