3. The Board of Directors considered the Memorandum and Recommendation of the President and approved, as recommended: a. The proposed 2024 administrative budget of USD280.5 million and capital budget of USD5.6 million.

#### **Consideration of Investment Projects**

The Board of Directors considered the Memorandum and Recommendation of the President and approved the proposed sovereign-backed policy-based financing (PBF), under the COVID-19 Crisis Recovery Facility, in the amount of USD670 million to the Republic of Uzbekistan for the "First Inclusive and Resilient Market Economy Development Policy Operation" (Project Number 000825), as recommended.
- 10. The Board of Directors considered the Memorandum and Recommendation of the President and approved the proposed sovereign-backed loan in the amount of EUR936.6 million to the Republic of Indonesia for the Modernization of Health System Project (Project Number 000787), as recommended.
- 11. The Board of Directors considered the Memorandum and Recommendation of the President and approved the proposed material change request to the nonsovereign-backed financing in the China FOSUN COVID-19 Vaccine Project (under the COVID-19 Crisis Recovery Facility) (Project Number 000534), as recommended.
- 12. The Board of Directors considered the Memorandum and Recommendation of the President and approved the proposed nonsovereign-backed investment of up to INR6,061.0 million (approximately equivalent to USD73 million) into an Infrastructure Investment Trust (InvIT) Sustainable Energy Infra Trust (SEIT, the Trust) under Project Meridian (Project Number 000776), as recommended. The Board of Directors noted and agreed with the delayed publication in these minutes of information relating to this project pending the satisfaction of regulatory or confidentiality requirements.
