

# **2022 Corporate Procurement Annual Report**

### **Executive Summary**

#### **Contract Overview**

- The total value of the Asian Infrastructure Investment Bank's (AIIB) corporate procurement contracts in 2022 is USD81,201,833 which is one percent higher than in 2021. A total of 675 contracts were awarded compared to 606 contracts in 2021.
- The procurement category with the largest spend is General Services accounting for 58 percent of the total contract value, followed by Consulting Services for 30 percent, Goods for 11 percent and Works for one percent.
- AIIB procures goods, works and services, including consulting services, through competition or direct selection. Competitive procurement represents 65 percent of the total contract value.
- Aside from regular one-off and multiyear contracts, AIIB executed eight framework agreements for the long-term supply of strategic goods and services.

### **2022 Corporate Procurement Activities**

- Completed 675 contracts to support AIIB's investment operations projects and meet the Bank's corporate requirements for goods, works and general/consulting services using the Bank's administrative and capital budget.
- Continuously enhanced eProcurement systems to enable upgraded functions in the ERP system.
- Issued internal guidance and implemented amendments to the Directive on Corporate Procurement to improve overall corporate procurement efficiency.
- Completed internal compliance assurance review on Know Your Counterparty/Financial Crime and Integrity Due Diligence (KYC/FCIDD) for Corporate Procurement Suppliers and completed KYC system business design including integration with eProcurement systems.
- Completed one external audit and two internal audits on Financial Reporting with no major findings.
- Completed annual planning report on Outsourcing Services.

#### 1. Introduction

The Annual Corporate Procurement Report provides an overview of AIIB's procurement of goods, works and services, including consulting services required by AIIB to fulfill its institutional requirements using the Bank's administrative budget, capital expenditure budget and other funding sources administered by AIIB.

This report was prepared by the Corporate Procurement Unit (CPU) of the Facilities and Administration Services Department. CPU exercises AIIB's corporate procurement functions and ensures compliance with the Bank's Policy on Corporate Procurement.


This report includes statistics on (i) AIIB's Corporate Procurement contract value by categories, (ii) top 10 contracts by value, (iii) procurement methods, (iv) global procurement and (v) engagement of Individual Consultants.

### 2. Corporate Procurement Contract Value

Based on AIIB's administration and operational requirements, the total corporate procurement contract value in 2022 is USD**81,201,833**, a slight 1-percent increase from USD80,790,844 in 2021.

## 4. Procurement Methods

A total of 239 contracts representing 65 percent of the total value of contracts were procured through competition, while 436 contracts representing 35 percent

of the total contract value were procured through direct selection. The exception to competitive procurement is in accordance with the AIIB Directive on Corporate Procurement section 3.7.


#### 5. Global Procurement

AIIB's Procurement Policy allows the Bank to procure goods, works, general services and consulting services from any country and region unless AIIB's Board of Directors decides otherwise. To implement the policy, AIIB provides an online facility for advertising business opportunities for goods and services including consulting services.

The top five supplier countries and regions (where their global head offices are registered) are China (56 percent), United States (12 percent), Germany (nine percent), the United Kingdom (five percent) and Switzerland (five percent). The top five represent 87 percent of the total contract value of suppliers.

International suppliers (including foreign companies outside China, wholly owned foreign enterprises registered in China) mainly provided consulting services and international subscription of IT products and associated services, while local suppliers provided mainly general services, including corporate services, security and building facility management, IT equipment and software, telecommunications, catering and local event management and staff relocation settlement services.

### 6. Engagement of Individual Consultants

In 2022, Individual Consultants continued to play an important role in supporting AIIB's operations in the areas of policy assurance and compliance, information technology, legal, investment project preparation and implementation.

The total number of individual consultant contracts concluded in 2022 is 345, a 34-percent increase compared to 2021. The overall contracted commitment Page 8 of 13

(including both consultants' remuneration and reimbursable expenses) reached USD15,360,612, a 5-percent increase compared to 2021. Consultants' total input days also increased by 6 percent compared to 2021. See Table 5 for detailed data.
