Executive Summary

2023 Contract Overview

- The total value of the Asian Infrastructure Investment Bank's (AIIB) corporate procurement contracts in 2023 was USD109,445,830, which is 35 percent higher than in 2022 and in 2021. A total of 877 contracts¹ were signed in 2023 compared to 675 contracts in 2022 and 606 contracts in 2021.
- The procurement category with the largest expenditure was General Services, accounting for 53 percent of the total contract value, followed by Consulting Services at 28 percent, Goods at 17 percent and Works at 2 percent.
- AIIB procures goods, works and services, including consulting services, through competition or direct selection. Competitive procurement represents 62 percent of the total contract value.
- Aside from regular one-off and multiyear contracts, AIIB executed 12 framework agreements for the long-term supply of strategic goods and general services.

2023 Corporate Procurement Activities

- AllB's Corporate Procurement Unit was restructured to the Corporate Procurement Division (CPD) in December 2023.
- Amendments to the Directive on Corporate Procurement and the Terms of Reference for the Corporate Procurement Committee have been proposed for consideration to improve overall corporate procurement efficiency.
- The annual planning report on Outsourcing Services was issued.
- In total, 877 contracts were signed to support AIIB's investment operations and meet the Bank's corporate requirements for goods, works, general services and consulting services using the Bank's administrative and capital budget.
- External and internal audits on Financial Reporting were completed with no major findings.
- Enhancements to eProcurement systems to streamline procurement procedures were implemented, including 41 enhancements to the Ariba system for recruitment of firms and 25 enhancements to the Fieldglass system for recruitment of individual consultants.

1. Introduction

The Annual Corporate Procurement Report provides an overview of AIIB's procurement of goods, works and services (including consulting services) required by AIIB to fulfill its institutional requirements using the Bank's administrative budget, capital expenditure budget and other funding sources administered by AIIB.

This report was prepared by the CPD of the Facilities and Administration Services Department (FAS). CPD exercises AIIB's corporate procurement function and ensures compliance with the Bank's Policy on Corporate Procurement.

This report includes statistics on: (i) AIIB's Corporate Procurement contract values by categories, (ii) top 10 contracts by value, (iii) procurement methods, (iv) global procurement and (v) engagement of individual consultants.

2. Corporate Procurement Contract Value

Based on AIIB's administrative and operational requirements, the total corporate procurement contract value in 2023 was USD**109,445,830.** Comparisons with the total corporate procurement contract value in 2021- 2023 are shown in the charts below:




Chart 1: Total Number and Value of Contracts, 2021-2023





Chart 2: 2023 Contract Value by Procurement Category

There was a relatively significant increase in the value of procurement of goods and consulting firms in 2023 compared with 2022. The increase is attributed to several large multiyear contracts such as the renewal of Microsoft Licenses and Standard and Poor Risk Data Services, Designated Network Leasing, Project Management Consultancy, IT Strategic Planning, Legal Advice, KYC Outsourcing Services, etc.

3. Top 10 Contracts by Value

The top 10 contracts accounted for 37 percent of the total contract value (excluding individual consultant contracts), presented in the table below:

4. Procurement Methods for Corporate Vendors

A total of 140 contracts and 52 contract amendments, representing 61 percent of the total contract value, were procured through competition. Meanwhile, 245 contracts and 58 contract amendments (representing the remaining 39 percent of the total contract value) were procured through direct selection, in accordance with the AIIB Directive on Corporate Procurement.

5. Global Procurement

AIIB's Procurement Policy allows the Bank to procure goods, works, general services and consulting services from any country and region unless AIIB's Board of Directors decides otherwise. To implement the policy, AIIB provides an online facility for advertising business opportunities for goods and services, including consulting services.

The top five supplier countries and regions (where their global head offices are registered) are China (52 percent); the United States (19 percent); the United Kingdom (8 percent); Germany (5 percent) and Hong Kong, China (4 percent). The top five represent 88 percent of the total contract value of suppliers.

International suppliers (encompassing foreign companies outside China and wholly owned foreign enterprises registered in China) primarily offered consulting services to support various aspects of project implementations. These services included project preparations, operational risk assessment, auditing and compliance-related services.

On the other hand, local suppliers predominantly provided general services, goods and works. These encompassed a wide range of offerings such as corporate services, training programs, security and building facility management, IT equipment and software, telecommunications services, catering services, event management and staff insurance and relocation settlement services.

6. Engagement of Individual Consultants

In 2023, individual consultants continued to play a significant role in supporting AIIB's operations. Departments with the highest spending on individual consultants were Strategy, Policy and Budget Department, Information Technology Department, Operational Services Department, the MCDF Secretariat and Infrastructure Investment Department (Region 1).

The total number of individual consultant contracts and contract amendments concluded in 2023 is 382, representing an 11-percent increase compared with 2022. The overall contracted commitment (including both consultants' remuneration and reimbursable expenses) reached USD16,383,301, a 7-percent increase compared with 2022. See Tables 4-7 for details.
