Executive Summary

Contract Value

- The total value of corporate procurement contracts in 2021 is USD**80,790,844** which is 28 percent higher than in 2020. A total of 606 contracts were awarded compared to 568 contracts in 2020.
- The procurement category with the largest spend is General Services accounting for 62 percent of the total contract value, followed by Consulting Services for 29 percent, Goods for seven percent and Works for two percent.

Procurement Approach

- AIIB procures goods, works and services, including consulting services, through competition or direct selection. Competitive procurement represents 65 percent of the total contract value compared to 60 percent in 2020.
- Aside from regular one-off and multiyear contracts, AIIB executed seven framework agreements for the long-term supply of strategic goods and services.

2021 Corporate Procurement Activities

- Completed 606 contracts to support AIIB's investment operations projects and meet the Bank's corporate requirements for goods, works and general/consulting services using the Bank's administrative and capital budget.
- Selected and commenced implementation for ERP upgrading to SAP S4Hana, to be integrated with two eProcurement systems (SAP Ariba and SAP Fieldglass).
- Issued revisions to Directive on Corporate Procurement and Administrative Guidance, in respect to AIIB's Corporate Efficiency review to meet specific challenges and improve overall efficiency in corporate procurement.
- Led by Compliance, jointly reviewed and revised the Administrative Guidance (AG) on "Know Your Counterparty/Financial Crime & Integrity Due Diligence (KYC/FCIDD) for Corporate Procurement, based on experience learned since the first issuance of its original version in March 2020 with the objective to enhance internal control measures.
- Completed two Audits on Internal Control on Financial Reporting and Audit on Outsourcing Services.

1. Introduction

The Annual Corporate Procurement Report provides an overview of AIIB's procurement of goods, works and services, including consulting services required by AIIB to fulfill its institutional requirements using the Bank's administrative budget, capital expenditure budget and other funding sources administered by AIIB.

In the height of the pandemic in 2021, AIIB's Corporate Procurement relied heavily on virtual meeting platforms and the Bank's eProcurement systems to ensure that work with requesting departments and suppliers continued without interruption.

This report was prepared by the Corporate Procurement Unit (CPU) of the Facilities and Administration Services Department. CPU exercises AIIB's corporate procurement functions and ensures compliance with the Bank's Policy on Corporate Procurement.

This report includes statistics on (i) AIIB's Corporate Procurement contract value by categories, (ii) top 10 contracts by value, (iii) procurement methods, (iv) global procurement and (v) engagement of Individual Consultants.

2. Corporate Procurement Contract Value

Based on AIIB's administration and operational requirements, the total corporate procurement contract value in 2021 is USD**80,790,844**, a 28-percent increase from USD63,062,832 in 2020.



The value of contracts for General Services accounted for 62 percent of the total contract value. Contracts for Consulting Services by firms (11 percent) and individuals (18 percent) constitute 29 percent of the total contract value. The remainder consists of contracts for Goods and Works.

The top 10 contracts accounted for 46 percent of the total contract value (excluding Individual Consultant contracts).

4. Procurement Methods

A total of 228 contracts representing 65 percent of the total value of contracts were procured through competition, while 378 contracts representing 35 percent of the total contract value were procured through direct selection. The exception to competitive procurement is in accordance with the AIIB Directive on Corporate Procurement section 3.7.2. Contracts awarded in 2021 through competition increased by five percent.

5. Global Procurement

AllB's Procurement Policy allows the Bank to procure goods, works, general services and consulting services from any country and district unless AllB's Board of Directors decides otherwise. To implement the policy, AllB provides an online facility for advertising business opportunities for goods and services including consulting services.

The top five supplier countries and districts (where their global head offices are registered) are China (61 percent); the United States (14 percent); Germany (seven percent); Hong Kong, China (five percent) and Singapore (four percent). The top five represent 91 percent of the total contract value of suppliers.




Chart 2: Top Five Supplier Countries and Districts (contract value in USD)

International suppliers (including foreign companies outside China, wholly owned foreign enterprises registered in China) mainly provided consulting services and international subscription of IT products and associated services, while local suppliers provided mainly general services, including administration, security and facility management, IT equipment and software, telecommunications, catering and local event management and staff relocation settlement services.

6. Engagement of Individual Consultants

In 2021, Individual Consultants continued to play an important role in supporting AIIB's operations in the areas of policy assurance and compliance, information technology, legal, investment project preparation and implementation.

The total number of individual consultant contracts concluded in 2021 is 258, an increase from previous years. The overall contracted commitment (including both consultants' remuneration and reimbursable expenses) reached USD14,586,803,

a 13.6 percent increase compared to 2020. Consultants' total input days also increased by 11.3 percent compared to 2020. See Table 5 for detailed data.
