- 1. The *Bangladesh Rural Electrification Board (BREB) intends to apply for* financing in the amount of US\$350 million equivalent from the Asian Infrastructure Investment Bank (AIIB or the Bank) toward the cost of the Modernization and Capacity Enhancement of BREB Network (Rajshahi & Rangpur Division), and it intends to apply part of the proceeds to payments for goods, works (Turn-key) to be procured under this project. Bangladesh Rural Electrification Board (BREB) is assigned by the Power Division, Ministry of Power, Energy & Mineral Resources (MoPEMR) to be responsible for the project implementation which will act as Project Implementing Entity (PIE).
