Any tender or modifications to tender (including discount) received outside e-procurement system will not be considered. The electronic tendering system would not allow any late submission of tender. The tender will be publicly opened online on the same day in the presence of the Tenderers' designated representatives and anyone who chooses to attend at the address below at 15.00 hours, and this could also be viewed by the tenderers online. If the office happens to be closed on the date of opening of the tenders as specified, the tenders will be opened on the next working day at the same time and venue.

Tender Security will have to be in any one of the forms as specified in the tendering document and shall have to be valid for 45 days beyond the validity of the tender.
