- **LOT-II:** Design, Supply, Fabrication, Erection, Testing and Commissioning of 2x25 kV OHE Works Between Panvel-Karjat Section (30 RKM and Approximate 88 TKM) of Central Railway Including EMU Stabling Sidings, Along with Supply of OHE Spares and T&P Items. (In connection with New suburban Corridor of Panvel-Karjat Section on Central Railway)
- The Government of India has received financing from the Asian Infrastructure Investment Bank (AIIB) toward the cost of the Mumbai Urban Transport Project – III (MUTP-III), and intends to apply part of the proceeds toward payments under the contract for "Design, Supply, Fabrication, Erection, Testing and Commissioning Of 2x25 kV OHE Works Between Virar-Dahanu Road Section (64 RKM and Approximate 155 TKM) of Western Railway and Panvel-Karjat Section (30 RKM and Approximate 88 TKM) of Central Railway, Including EMU Stabling Sidings, Along with Supply of OHE Spares and T&P Items" through both the lots.
- 2. The Mumbai Railway Vikas Corporation Ltd. now invites online Tenders through e-trending eligible Tenderers for Lot-I and Lot-II. Project under MUTP-III, the completion period of work is 36 months (i.e. 1095 days) for Lot-I and 24 months (i.e. 730 days) for Lot-II as detailed in the Table below. The tenderers may submit tenders for either or both the lots indicated therein. Tenderers are advised to note the clauses on eligibility (Section I Clause 4) and minimum qualification criteria for individual Lot (Section III Evaluation and Qualification Criteria), to qualify for the award of the contract. In addition, please refer to paragraphs 5.9 of the "Procurement Policy of January 2016" and paragraph 4.4 of "interim Operational Directive on Procurement

Instructions for Receipts, June 2016" setting forth the Asian Infrastructure Investment Bank's policy on conflict of interest.

- 3. Tendering will be conducted through National Open Competitive Tender (NOCT) using Invitation for Tenders (IFT) as specified in the Bank's Procurement Instructions for Recipients" (PIR) and is open to all eligible Tenderers as defined in this tender document.
- 4. Interested eligible Tenderers may obtain further information from undersigned during office of General Manager (Electrical) and inspect the tender document during office hours 10.00 to 18.00 Hours (IST) at the address given end of IFT.
- 5. The Tender document in English is available online on e-procurement portal <u>https://eprocure.gov.in</u> from 29/02/2024 at 18.00 hrs. IST till 15/04/2024 at 12.30 hrs. IST. The start date of submission of tender on e-procurement website is on 06/04/2024 at 12.30 hrs. IST. A Tenderer who desires to participate in the Tender will be required to register on the website. The Tenderers would be responsible for ensuring that any addenda available on the website is also downloaded and incorporated. Tenderer must submit the tender only on e-procurement website <u>https://eprocure.gov.in</u>.
- 6. For submission of the tenders, the tenderer is required to have Digital Signature Certificate (DSC) from one of the Certifying Authorities (CAs), authorized by Government of India for issuing DSC. Tenderers can see the list of licensed CAs from the link (<u>www.cca.gov.in</u>). Aspiring tenderers who have not obtained the user ID and password for participating in e-procurement in this Project, may obtain the same from the website: <u>https://eprocure.gov.in</u>.
- 7. Tender comprises two Parts, namely the Technical Part and the Financial Part, and both parts must be simultaneously submitted for both the Lots online on https://eprocure.gov.in on or before 15/04/2024 at 12.30 hrs. IST. The tender validity shall be 180 days after the last date of submission of tenders. Any tender or modifications to tender (including discount) received outside e-procurement system will not be considered. The electronic tendering system would not allow any late submission of tenders. The "TECHNICAL PART" of the Tenders will be publicly opened online on the 15/04/2024 at 15.30 hrs. IST in the presence of the Tenderers' designated representatives and anyone who chooses to attend at the address below, and this could also be viewed by the tenderers online on e-procurement portal. The "FINANCIAL PART" shall remain encrypted from in the e-procurement system until the second public Tender opening for the financial part. If the office happens to be closed on the date of opening of the tenders as specified, the tenders will be opened on the next working day at the same time and venue.
- 8. All Tenders must be accompanied by a Tender Security of the amount in the currency specified for the Work in the table at the end of this IFT. Tender Security can be submitted in the form of unconditional Bank Guarantee or FDR or Demand Draft in INR as per Clause ITT 21.3 of TDS. Tender security shall have to be valid for 45 days beyond the validity of the tender. In case the Tenderer has opted for Tender security in the form of an unconditional Bank guarantee, the Tenderer should upload the scanned copy of Bank Guarantee or FDR or Demand Draft in with the Tender. The original tender security documents in approved form shall be submitted as per the procedure described in paragraph 9 below.
- 9. The tenderers are required to submit (a) original tender security in approved form; (b) original affidavit regarding correctness of information furnished with tender document; and (c) Original Power of Attorney (POA) in favour of Authorized Signatory, with General Manager (Electrical), Mumbai Railway Vikas Corporation Ltd. 2nd Floor, Churchgate Station Building, Churchgate, Mumbai-400020, either by registered post/ speed post/ courier/ by hand on or before tender submission date and time, failing which such tender will be declared non-responsive. The employer, MRVC, is not responsible for any delay in submission of original documents.

- 10. A pre-tender meeting will be held on 12/03/2024 at 15.00 hrs. IST at the office of Mumbai, Railway Vikas Corporation Ltd. 2nd Floor, Churchgate Station Building, Churchgate, Mumbai 400020 as well as on video conferencing (the link / id to join will be intimated through email) to clarify the issues and to answer questions on any matter that may be raised at that stage as stated in ITT Clause 7.4 of 'Instructions to Tenderers' of the tender document. Tenderers are advised to download the tender document prior to the pre-tender meeting for tenderers to have a good understanding of the scope of the requirements under this contract for discussion and clarification at the pre-tender meeting. The last date for submission of Pre-Tender queries to the Employer is 11/03/2024 by 18.00 hrs. IST after which no queries will be acknowledged. MRVC's response to Pre-tender queries will be uploaded on 18/03/2024
- 11. Tenderer may bid for any Lot or for both the Lots of their choice and are invited to offer discounts in their bid. To be eligible for an award of the contract for more than one bid, the tenderer is required to meet the sum of the qualification requirements for these bids. Discount to be offered if any, shall be mentioned in the last sheet named as discount sheet. Discount sheet of bill of quantities (BOQ) /Activity Schedule to be uploaded in financial part.
- 12. The Employer shall not be held liable for any delays due to system failure beyond its control. Even though the system will attempt to notify the tenderers of any tender updates, the Employer shall not be liable for any information not received by the tenderer. It is the tenderers' responsibility to verify the e-procurement website (https://eprocure.gov.in). for the latest information related to this tender.
