Any tender or modifications to tender (including discount) received outside e-procurement system will not be considered. The electronic Tendering system would not allow any late submission of tender. The "TECHNICAL PART" of the Tenders will be publicly opened online on the same day in the presence of the Tenderers' designated representatives and anyone who chooses to attend at the address below at 15.30 hours (IST), and this could also be viewed by the tenderers online. The "FINANCIAL PART" shall remain unopened in the e-procurement system until the Tender opening for the financial part. If the office happens to be closed on the date of opening of the tenders as specified, the tender will be opened on the next working day at the same time and venue.
