The Ministry of Health (MoH) Republic of Indonesia as the Executing Agency has applied for financing in the amount of US\$3.133 billion equivalent from joint co-financing the World Bank (WB), Asian Development Bank (ADB) and Asian Infrastructure Investment Bank (AIIB) toward the cost of the Indonesia-Modernization of the Health System Project, and it intends to apply part of the proceeds to payments for goods, non-consulting services and consulting services to be procured under this proposed project.

The project consists of the following components:

Component 1: Procurement, installation, operation, and maintenance of equipment to primary care facilities across Indonesia, specified as Strengthening of Primary Healthcare in Indonesia (SOPHI) component.

Supports the procurement, distribution, installation, operational support and maintenance of energyefficient Equipment for integrated healthcare centers (*Posyandu*), public auxiliary health centers (*Pustu*), public primary health centers (*Puskesmas*), and Tier 1 public health laboratories with a focus on emergency procedures, dental, maternal and child health equipment.

Component 2: Procurement, installation, operation, and maintenance of equipment to referral hospital facilities across Indonesia, specified as Strengthening Indonesia's Healthcare Referral Network (SIHREN) component.

Supports the procurement, distribution, installation, operational support and maintenance of energyefficient Equipment, for Madya, Utama, and Paripurna hospitals

Component 3: Procurement, installation, operation, and maintenance of equipment to tier 2, 3, 4, and 5 public health laboratory facilities across Indonesia, specified as Indonesia – Public Laboratory System Strengthening (InPULS) component.

Supports the procurement, distribution, installation, operational support and maintenance of energyefficient Equipment for Tier 2, 3, 4, and 5 public health laboratories.

**Component 4: Project Management, Administration, Digitization and Training across the SOPHI, SIHREN, and InPULS components.** 

Supports the provision of support to the establishment and operation of Central Project Management Unit (CPMU), Central Procurement Unit (CPU), and Project Management Units (PMUs) in managing Project activities under Parts 1, 2 and 3, including *inter alia*, through provision of technical assistance and Incremental Operating Costs to support: (a) IT support teams; (b) project management and administration; (c) monitoring and evaluation (M&E) activities; (d) FM and audit; (e) procurement; (f) environmental and social risk management; (g) interventions designed to promote gender inclusion and equity in health service availability, accessibility, and quality; (h) development of integrated data systems for facilities readiness assessment and managing inventories; (i) development of data systems and monitoring of health facilities readiness and equipment functionality; and (j) essential human resources for health (HRH) trainings

Procurement of contracts financed by the World Bank, ADB and AIIB will be conducted through the procedures as specified in the World Bank's Procurement Regulations for IPF Borrowers (Procurement Regulations) of September 2023, and is open to all eligible firms and individuals as defined in the Procurement Regulations. The World Bank, ADB and AIIB shall arrange the publication on its external website of the agreed initial procurement plan and all subsequent updates once it has provided a no objection. The agreed procurement plan shall also be published on the MoH's website.

Specific Procurement Notices (SPN) for contracts subject to open international competitive procurement will be announced, as they become available, in UN Development Business online, on the World Bank, ADB and AIIB's external website and MoH's website, while for national open competitive procurement, SPN will be published in government e-procurement system. Rated criteria will be required for evaluation of bids under international competitive procurement.
