Part of this financing will be used for payments under the Contract named above. Bidding is open to Bidders from all countries, with exceptions specified in the Bidding Document.
- The Department of Public Works and Highways ("the Employer") invites sealed bids from eligible Bidders for the construction and completion of Contract Package 1 - Construction of Bataan Land Approach within Nine Hundred Thirteen (913) calendar days [30 months] from the commencement date of the Works.
