#### **Brief Description of the Project:**

The Bataan - Cavite Interlink Bridge (BCIB) Project involves the construction of a 32.15 kms, four (4) lane (2 lanes each direction) bridge starting from Barangay Alas-asin in Mariveles, Bataan crossing Manila Bay and terminating in Barangay Timalan, Naic, Cavite. It involves construction of two (2) navigation bridges - the North Navigation Channel Cable-Stayed Bridge and South Navigation Channel Cable-Stayed Bridge with main span of 400 m and 900 m, respectively.

The BCIB Project is one of the priority projects and is part of significant socioeconomic policy reforms, aiming to boost the economy by investing in key infrastructures and industries of the country. The BCIB Project targets to reduce poverty, encourage economic growth, and reduce congestion in Metro Manila, and the Project was prioritized in a view that it would (i) improve road network and connectivity, therefore eventually (ii) contribute to economic growth of the project regions, which play a significant role in the country's economy.

The BCIB Project will be jointly co-financed by the Asian Development Bank (ADB) and the Asian Infrastructure Investment Bank (AIIB). For ADB financing, a multitranche financing facility (MFF) will be used with three (03) tranches or loans; whereas AIIB will provide loans in three (03) phases.

The project shall be implemented over six (6) years, with an expected start of operation in the end 2029. Future potential connection to the Corregidor Island is possible, if desired, as the design can accommodate a viaduct roadway connection.
