### Procurement of Health Sector Goods

1. The Government of the Democratic Socialist Republic of Sri Lanka has received financing in the amount 100 million United States Dollars from the Asian Infrastructure Investment Bank (AIIB or the Bank) toward the cost of the Emergency Health Components of: (i) SCURP; and (ii) RLVMMP under Ministry of Health and intends to apply part of the proceeds toward the payments for purchasing health sector goods/ medical supplies, such as (i) Pharmaceuticals; (ii) Surgical Consumables & (iii) Laboratory Reagents/consumables.
2. Procurement of contracts financed by AIIB will be conducted through the following procedures:
  - (i) International Open Competitive Tendering (IOCT)
  - (ii) National Competitive Tendering (NCT); and
  - (iii) Request for Quotations (RFQ)

as specified in the AIIB's Interim Operational Directive on Procurement Instructions for Recipients (June 2, 2016) and is open to all eligible tenderers as defined in the Instructions.

**Please note that the health sector goods supplied has to be manufactured outside Sri Lanka.**

3. Specific procurement notices for contracts to be tendered under the AIIB's IOCT and NCT procedures will be prepared, and as they become available, will be published on the AIIB's website, local newspapers and in addition, for IOCT packages only, on the United Nations Development Business (UNDB)'s website. RFQs will be directly issued to suppliers registered with the National Medicines Regulatory Authority (NMRA) and also published on the HSEP's and the Ministry of Health's websites for any qualified suppliers to participate in the tendering process.

Interested eligible manufacturers/suppliers and their local agents who would wish to be included on the supplier list for the procurement of medical supplies/health sector goods for the above-mentioned project, are requested to submit the information as per the attached format on or before 21<sup>st</sup> November 2023 to the following address and may obtain additional information about this Project as well.
