Bukhara Region Water Supply and Sanitation Project (Phase II)

The Republic of Uzbekistan has applied for financing in the amount of US\$ 248.4 million from the Asian Infrastructure Investment Bank (AIIB) toward the cost of the Bukhara Region Water Supply and Sanitation Project, and it intends to apply part of the proceeds to payments for goods, works, non-consulting services and consulting services to be procured under this project. The Government of Uzbekistan has entrusted the project to JSC “Uzsuvtaminot” for the project implementation.

The project will include the following components and the procurement that requires international competition for this Project and will include the following components:

Component 1 — Investment in Water Supply Infrastructure: Constructing and rehabilitating of main water lines, well fields and intakes, associated electric facilities, water treatment facilities, pumping stations, water reservoirs, distribution networks in three districts of Bukhara region (Gijjdvuvon, Vobkent and Shofirkon), house connections and equipment.

Component 2 — Investment in Sewerage Infrastructure: Constructing of centralized sewage system in district centers consisting of house connections, collectors, pumping stations and mechanical-biological sewerage treatment plants as well as discharge facilities in six district centers of Bukhara region (Gala-Osiyo district center of Bukhara district, Jondor, Shofirkon and Vobkent districts centers, the Yangibozor district center of Peshkue district and Kogon city) and sewerage network extension in the city of Bukhara, optionally tertiary treatment for reuse purpose.

Component 3 — Project Implementation and Management Support: Assisting the Project Implementing Entity in ensuring seamless coordination, efficient implementation and compliance with the relevant policies and standards and the Incremental Operating Costs for the phase II sub-group within the PCU.

Procurement of contracts financed by AIIB will be conducted in accordance with the AIIB Procurement Policies and its associated Procurement Directive (June 2, 2016) (“Procurement Directive”), and is open to all eligible firms and individuals as defined in the Procurement Directive.

Specific procurement notices for contracts subject to open international competitive procurement will be announced, as they become available, on www.tenderweek.com, AIIB external website and UNBD portal, as appropriate.
