2. The Dhaka Electric Supply Company Ltd. (DESCO) (the purchaser) now invites sealed Tenders from eligible Tenderers for the supply and delivery of the following plants:

3. An international open competitive tender will be conducted in accordance with AIIB's Single-Stage Two-Envelope procedure and is open to all Tenderers from eligible source countries as defined in the AIIB's Interim Operational Directive: Procurement Instructions for Recipients.
4. Interested eligible Tenderers may obtain further information from Dhaka Electric Supply Company Ltd. (DESCO) and inspect the Tender Document at the address given below, from 10:30 O'clock morning to 03:30 O'clock evening on all working days.

The Tender Document, in English Language, may be purchased by the interested Tenderers on Submission of a written application to the address below and upon payment of non-refundable fee of \$250.00 (Two Hundred Fifty) or equivalent Bangladeshi Tk. 20,000.00 (Twenty Thousand) only. The method of payment will be in the form of Demand Draft or Pay Order in favor of Dhaka Electric Supply Company Ltd. (DESCO) for each Tender Document. The document will be sent by hand to the Tenderer or their representative. The document may be sent surface mail or courier service. Interested Tenderers who are requesting international courier dispatch should pay an additional fee of USD 100.00. No liability will be accepted for loss or late delivery.
