  - 2.7. The Tenderer must demonstrate that it has (or has at its disposal) financial resources such as: liquid assets, unrestricted fixed assets, lines of credit and other financial assets, excluding advance payments for the contract, and should also meet: a cash flow requirement of not less than RMB 46 million or USD 6 million.

- 2.8. The vehicle manufacturer must have at least 5 years of experience in the production of pure electric vehicles.
- 2.9. The Tenderer submits with the tender documents 2 completed projects similar to this project in the last 5 years (2017-2021) (similar scale, complexity, number of vehicles, after-sales service, etc.), the amount of each of the 2 projects must be no less than RMB 75 million or USD 9.7 million, and no less than 100 pure electric buses.
