The government of India has applied for financing in the amount of USD 490 million equivalents from the Asian Infrastructure Investment Bank (AIIB) toward the cost of the Assam Intra-State Transmission System Enhancement Project, and it intends to apply part of the proceeds to payments for goods, works, non-consulting services and consulting services to be procured under this project.

The project is expected to include the following components:

- **Component 1.** Construction of new extra high voltage 400 kV, 220 kV and 132 kV grid substations along with the associated transmission lines.
- **Component 2.** Upgradation of existing substations and transmission lines, and replacement of existing ground wire by OPGW.
- **Component 3.** Technical Assistance such as a) engaging consulting services to strengthen Project Management, b) Capacity building activities and c) Setting up of Enterprise Resource Planning (ERP).

Procurement of contracts financed by the AIIB will be conducted through the procedures as specified in the Bank's Procurement Policy and associated INTERIM OPERATIONAL DIRECTIVE on Procurement Instruction for Recipients (PIR), and its open to all eligible firms and individuals.

Specific procurement notices for contracts subject to International open Competitive Tender (IoCT) will be announced, as they become available, in <u>UN Development Business</u> online, on the AIIB's external website <u>www.aiib.org</u>, in addition to AEGCL's website <u>www.aegcl.co.in</u>.
