- 1. The Government of India has received financing from Asian Infrastructure Investment Bank (AIIB) toward the cost of the Mumbai Urban Transport Project (MUTP) - III, and intends to apply part of the proceeds toward payments under the contracts for "Construction of Station buildings, service buildings, New Platforms, New FOBs, Staff quarters, Tower wagon shed; Extension of existing platforms, existing FOBs, bridges; earthwork for Railway formation; and dismantling of existing structures at various stations in connection with Quadrupling of Virar-Dahanu Road of balance 2 LOTs."
- 2. Mumbai Railway Vikas Corporation (MRVC) Ltd. an implementing agency now invites online Tenders from eligible Tenderers for Construction of Station buildings, service buildings, New Platforms, New FOBs, Staff quarters, Tower wagon shed; Extension of existing platforms, existing FOBs, bridges; earthwork for Railway formation; and dismantling of existing structures at various stations in connection with Quadrupling of Virar-Dahanu Road through balance 2 LOTs as detailed in the Table below.

Tenderers may bid for any one lot or both lots as per their choice as further defined in the tender document. Tenderer wishing to offer discount in case they are awarded more than one contract will be allowed to do so, provided those discounts are included in the Letter of Tender – Financial Part. To be eligible for an award of contract for more than one lot, the tenderer is required to meet the sum of the qualification requirement of both lots. The decision to consider tenderer for award of a particular lot or both lots as per their eligibility will be of the employer based on overall financial advantage to the employer (Lowest cost to the employer). However, Tenderers should mention order of preference of individual lots, for due consideration by employer during tender evaluation.

Tenderers are advised to note the clauses on eligibility (Section I Clause 4) and minimum qualification criteria (Section III – Evaluation and Qualification Criteria), to qualify for the award of the contract. In addition, please refer to paragraphs 4.4 of the "Interim Operational Directive on Procurement Instructions for Recipients" setting forth Asian Infrastructure Investment Bank's policy on conflict of interest.

Tendering will be conducted through International Open Competitive Tender (IoCT) using Request for Tenders (RFT) as specified in the Asian Infrastructure Investment Bank's "Procurement Policy of January 2016" and "Interim Operational Directive on Procurement Instructions for Receipts, June 2016", and is open to all eligible Tenderers.
- 4. Interested eligible Tenderers may obtain further information from Shri Vilas S. Wadekar, Executive Director/ Civil, Mumbai Railway Vikas Corporation Ltd. (E-mail: <u>edcivil@mrvc.gov.in</u>) and inspect the Tender Document during office hours from 10.00 to 17.00 hrs. at the address given below.
- 5. The Tender Document in English is available online on <u>https://eprocure.gov.in</u> from 06-10-2022 to 25-11-2022 for interested eligible tenderers for a non-refundable fee as indicated in the table below. The method of payment will be demand draft/ cashier's check/ certified check payable at Mumbai in favour of "Mumbai Railway Vikas Corporation Ltd." or direct deposit to MRVC Bank account number as mentioned below. Payment documents are to be submitted as per the procedure described in paragraph 9 below. Tenderers will be required to register on the website. The Tenderer would be responsible for ensuring that any addenda available on the website is also downloaded and incorporated. Tender document is also available for information on official website of MRVC <u>www.mrvc.indianrailways.gov.in</u>. However, Tenderer has to submit the offer only on e-procurement website <u>https://eprocure.gov.in</u>.
- 6. For submission of the tenders, the tenderer is required to have Digital Signature Certificate (DSC) from one of the Certifying Authorities (CAs), authorized by Government of India for issuing DSC. Tenderers can see the list of licensed CAs from the link (<u>www.cca.gov.in</u>). Aspiring tenderers who have not obtained the user ID and password for participating in e-procurement in this Project, may obtain the same from the website: <u>https://eprocure.gov.in</u>.
- 7. Tenders comprise two Parts, namely the Technical Part and the Financial Part, and both parts must be simultaneously submitted online on <u>https://eprocure.gov.in</u> (website) on or before 12.00 Hrs. of 25-11-2022. Any tender or modifications to tender (including discount) received outside e-procurement system will not be considered. The electronic

tendering system would not allow any late submission of tender. The "TECHNICAL PART" of the tender will be publicly opened online on the same day in the presence of the Tenderers' designated representatives and anyone who chooses to attend at the address below at 15.00 hours, and this could also be viewed by the tenderers online. The "FINANCIAL PART" shall remain unopened in the e-procurement system until the second public tender opening for the financial part. If the office happens to be closed on the date of opening of the tenders as specified, the tenders will be opened on the next working day at the same time and venue.

- 8. All Tenders must be accompanied by a Tender Security of the amount specified for the Work in the table below, drawn in favour of "Mumbai Railway Vikas Corporation Ltd." Tender Security will have to be in any one of the forms as specified in the tendering document and shall have to be valid for 45 days beyond the validity of the tender. (The original Tender Security documents in approved form shall be submitted as per the procedure described in paragraph 9 below).
- 9. The tenderers are required to submit (a) original payment documents towards the cost of tendering document and registration on e-procurement website (if applicable); (b) original tender security in approved form; and (c) original affidavit regarding correctness of information furnished with tendering document, with Executive Director/ Civil, Mumbai Railway Vikas Corporation Ltd., Second Floor, Churchgate Railway Station Building, Mumbai 400 020 before the Tender opening deadline given above, either by registered post/speed post/courier or by hand in sealed cover, failing which such tenders will be declared non-responsive, and will not be opened. The employer, MRVC is not responsible for any delay in submission of the original document. Ensuring that these documents reach the concerned MRVC official in time is sole responsibility of the tenderer.
- 10. A pre-tender meeting will be held on 18-10-2022 at 15.00 Hrs. at the office of Mumbai Railway Vikas Corporation Ltd., Second Floor, Churchgate Railway Station Building, Mumbai 400 020 to clarify the issues and to answer questions on any matter that may be raised at that stage as stated in ITT Clause 7.4 of 'Instructions to Tenderers' of the tendering document. Tenderers are advised to download the tendering document prior to the pre-tender meeting in order, for tenderers to have a good understanding of the scope of the requirements under this contract for discussion and clarification at the pre-tender meeting.

Even though the system will attempt to notify the tenderers of any tender updates, the Employer shall not be liable for any information not received by the tenderer.
