1. The Government of India has applied for from the Asian Infrastructure Investment Bank (AIIB) towards the cost of the MUMBAI URBAN TRANSPORT PROJECT (MUTP)- IIIA and intends to apply part of the proceeds toward payments under the contract for “**Improvement of Stations including provision of FOBs, elevated decks, inter connections between Deck/FOBs, skywalks, relocation of service buildings, stalls, kiosks etc., improving entry/exit, improving circulating areas, provision of green spaces, etc., at various stations of Central Railways**”.
2. The Mumbai Railway Vikas Corporation Ltd. (MRVC), an implementing agency, now invites online Tenders from eligible Tenderers for the project “**Improvement of Stations including provision of FOBs, elevated decks, inter connections between Deck/FOBs, skywalks, relocation of service buildings, stalls, kiosks etc., improving entry/exit, improving circulating areas, provision of green spaces, etc., at various stations of Central Railways**” for under mentioned works through balance 3 (three) lots-

\*Tenderers may bid on any lot or combination of lots of their choice and are invited to offer discounts in case they are awarded more than one lot. To be eligible for an award of contract for more than one lot, the tenderer is required to meet the sum of the qualification requirement for these lots. The decision to consider him for award of a particular lot or combination of lots as per his eligibility will be of the employer based on overall financial advantage to the employer (Lowest cost to the employer). However, Tenderers should mention in letter of tender (technical part), the order of preference of individual lots, for due consideration by employer during tender evaluation.

3. Tendering will be conducted through International Open Competitive Tendering procedures (IOCT) as specified in the Bank's Procurement Instructions for Recipients (PIR) and is open to all eligible Tenderers as defined in the PIR.
4. Interested eligible Tenderers may obtain further information from Mr.Guru Prakash, GM (Procurement), Mumbai Railway Vikas Corporation Ltd. (E-mail: [gmprocurement@mrvc.gov.in](mailto:gmprocurement@mrvc.gov.in)) and inspect the Tender Document during office hours from 1000 to 1700 hrs. at the address given below.
5. The Tender Document in English is available online on <https://eprocure.gov.in> from 07-06-2023 to 17-07-2023 for interested eligible tenderers. Tenderers will be required to register on the website. The Tenderer would be responsible for ensuring that any addenda available on the website is also downloaded and incorporated. Tender document is also available for information on official website of MRVC [www.mrvc.indianrailways.gov.in](http://www.mrvc.indianrailways.gov.in). However, Tenderer has to submit the offer only on e-procurement website <https://eprocure.gov.in>.
6. For submission of the tender, the tenderer is required to have Digital Signature Certificate (DSC) from one of the Certifying Authorities (CAs), authorized by Government of India for issuing DSC. Tenderers can see the list of licensed CAs from the link ([www.cca.gov.in](http://www.cca.gov.in)). Aspiring tenderers who have not obtained the user ID and password for participating in e-procurement in this Project, may obtain the same from the website: <https://eprocure.gov.in>.

7. Tenders comprise two Parts, namely the Technical Part and the Financial Part, and both parts must be simultaneously submitted online on <https://eprocure.gov.in> (website) on or before 12.00 Hrs. of 17-07-2023. Any tender or modifications to tender (including discount) received outside e-procurement system will not be considered. The electronic tendering system would not allow any late submission of tender. The “TECHNICAL PART” of the tender will be publicly opened online on the same day in the presence of the Tenderers’ designated representatives and anyone who chooses to attend at the address below at 15.00 hours, and this could also be viewed by the tenderers online. The “FINANCIAL PART” shall remain unopened in the e-procurement system until the second public tender opening for the financial part. If the office happens to be closed on the date of opening of the tenders as specified, the tenders will be opened on the next working day at the same time and venue.
8. All Tenders must be accompanied by a Tender Security of the amount specified for the Work in the table below, drawn in favour of “Mumbai Railway Vikas Corporation Ltd.” Tender Security will have to be in any one of the forms as specified in the tendering document and shall have to be valid for 45 days beyond the validity of the tender. (The original tender security documents in approved form shall be submitted as per the procedure described in paragraph 9 below).
9. The tenderers are required to submit (a) original tender security in approved form; and (b) original affidavit regarding correctness of information furnished with tender document, with GM(Procurement), Mumbai Railway Vikas Corporation Ltd. , Second Floor, Churchgate Railway Station Building, Mumbai – 400 020 before the Tender opening deadline given above, either by registered post/speed post/courier or by hand in sealed cover, failing which such tenders will be declared non-responsive, and will not be opened. The employer, MRVC is not responsible for any delay in submission of the original document. Ensuring that these documents reach the concerned MRVC official in time is sole responsibility of the tenderer.
10. A pre-tender meeting will be held on 21-06-2023 at 12.00 Hrs. at the office of Mumbai Railway Vikas Corporation Ltd., Second Floor, Churchgate Railway Station Building, Mumbai – 400 020 to clarify the issues and to answer questions on any matter that may be raised at that stage as stated in ITT Clause 7.4 of ‘Instructions to Tenderers’ of the tender document. Tenderers are advised to download the tender document prior to the pre-tender meeting in order, for tenderers to have a good understanding of the scope of the requirements under this contract for discussion and clarification at the pre-tender meeting.
11. Other details can be seen in the tender document. The Employer shall not be held liable for any delays due to system failure beyond its control. Even though the system will attempt to notify the tenderers of any tender updates, the Employer shall not be liable for any information not received by the tenderer. It is the tenderers’ responsibility to verify the website for the latest information related to this tender.
