**Assignment Title:** HIRING OF CONSULTANTS FOR CONSTRUCTION SUPERVISION OF THE PROJECT

The Islamic Republic of Pakistan has applied for financing from the Asian Infrastructure Investment Bank (AIIB) toward the cost of the “Lahore Water and Waste Water Management Project”, and intends to apply part of the proceeds for consulting services for resident supervision of construction of new syphon on River Ravi, intake structures, gates, raw water channel and its ancillary works.

The general scope of consulting services will include but not limited to:

- Carry out all required additional surveys and investigations if needed, review the engineering / detailed designs developed by the design consultants, update them as required and prepare construction drawings thereof.
- Supervise the construction works relating to construction of new syphon, intake structures, gated and raw water channel and its ancillary works in the capacity of “the engineer” : and undertakes tasks as defined in Multilateral Development Bank Harmonized Edition (June 2010) for FIDIC General Condition of contract for Construction.
- Implement the social and environmental safeguards following the project documents and the AIIB Safeguard Policy Statement.

The implementation period of assignment is 36 months and expected start date of assignment will be 30 OCT 2021.

The Executive Engineer, Chakbandi Division, of Lahore Zone, Lahore on behalf of Irrigation Department, Government of Punjab now invites eligible, experienced national and international consulting firms (“Consultants”) to indicate their interest in providing such Services. Interested consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform such services. The shortlisting criteria are:

- General experience of the firm
- Provision of design and construction supervision services for at least three similar assignments. Similar assignments would include large-scale irrigation infrastructure works including headworks, regulating structures, canals, siphon/aqueducts etc. The completion date of each assignment shall be within last 10 years and the construction value of each assignment shall be at least USD10 million. Key experts will not be evaluated at the shortlisting stage.
- Average audited annual financial turnover in the last 3 years.

Interested firms having sufficient experience of undertaking the assignment should submit the EOI along with the following information in English language stating background of their organization and professional experts:

- Name, address, telephone and fax numbers and email address of consultants.
- Ownership and organizational structure of the consultant.
- List of similar assignments substantially completed during the last ten years (Covering design and construction supervision services) indicating (i) Project cost and the cost of consultancy services (ii) Share of assignment in the case of joint venture (iii) Key staff time input and (iv) Description of nature and scope of work.
- List and provide CVs of key relevant staff permanently employed with the firm
- Audited statements of accounts and annual turnover for the last three (03) years.
- Certificate of incorporation/ constitution of the firm as legal entity.
- Registration of firm with relevant professional body
- National/international Tax number.
- Undertaking that the firm has not been sanctioned or declared ineligible by AIIB.

Consultants are requested to provide only that material which is specific to the proposed services and avoid submitting generic promotional literature.

The attention of interested Consultants is drawn to Section II, paragraphs 4.4, 4.42 and 13.4 of AIIB's "Procurement Instructions for Recipients" June 2, 2016, setting forth the AIIB's policy on conflict of interest. Available at AIIB's web-site.

Consultants may associate with other firms to enhance their qualifications, but should indicate clearly whether the association is in the form of a joint venture and/or a sub-consultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.

A Consultant will be selected in accordance with the Quality and Cost Based Selection (QCBS) method set out in the AIIB Procurement Instructions for Recipients.
