The Ministry of Urban Development and Housing has received financing from the Asian Infrastructure Investment Bank (AIIB). Accordingly, it is intended to apply part of the proceeds for consultancy services to the Support to Colombo Urban Regeneration Project on Community Mobilization, Capacity Improvement and Livelihood Restoration Development of Families, to be and/or Resettled.

This consultancy will help to uplift the social-economic situation of the Project Affected People's (PAP's) using an appropriate participatory community base approach to analyze existing livelihoods, determine their economic and social viabilities. This will be based on a gender responsive household approach and with relevant to that organization should implement the economic development programs not only that but also, they should concern all other aspects with relevant to all age limits and gender based.

The time period for this assignment is 3 years.

Eligible consulting firms are invited to indicate their interest in providing the services.

Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the services.

The shortlisting criteria are:

- 1.Average Net profit margin should be positive during the last three years (2017 to 2019).**
- 2.At least 3 similar assignments (Community Mobilization, Capacity Development and Livelihoods development programme types, with at least two of these forming parts of IFI financed Projects) in the last 10 years.**
- 3.Experience of working with communities that are relocated into housing projects (3 projects experience in the last 5 years 2015 to 2019).**
- 4.Geographic experience (Working Experience on at least 3 similar assignments in any South Asian Country).**
- 5.Technical and Management competence of the Firm.**

Key Experts will not be evaluated at the shortlisting stage.

The attention of interested Consultants is drawn to Section II, paragraph 4.4, and paragraph 4.9 of the AIIB's "Procurement Instructions for Recipients" June 2, 2016, setting forth the AIIB's policy on conflict of interest and eligibility.

Consultants may associate with other firms to enhance their qualifications, but should indicate clearly whether the association is in the form of a joint venture and/or a sub-consultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.
