2. Project Summary and Objectives

The project supports the Government of Sri Lanka's (GoSL) Urban Regeneration Program (URP), launched in 2011, aimed at improving housing conditions and services as well as reducing inefficient land use in the city of Colombo by resettling roughly 50,000 low-income and lower-middle-income households from low-rise neighborhoods into high-rise apartment complexes. This is intended to free up centrally located land for public purposes such as urban infrastructure and parks as well as commercial redevelopment. The proposed Project is supporting Phase III of the URP and will also address key technical, financial, environmental, social and other policy issues with the aim of improving the efficiency, equity and sustainability of the larger program.

5. Project Implementation Update

The project has faced some delays with regards to procurement and preparation of the first two Resettlement Action Plans (Obeyesekerapura and Madampitiya). The government's decision in January 2020 to replace the Project Director as well as the impacts of COVID-19 have resulted in further delays in 2020 still not replaced.

With the appointment of Acting Projector Director in April 2020 and the lifting of some of the movement restrictions, implementation progress has since resumed but the PMU remains understaffed and Project Management Support Consultants (PMSC) to the PMU is not yet mobilized due to vacuum at the PMU level with an Acting Project Director following the departure of the Project Director as well as understaffed PMU without anyone dedicated to process the several steps of recruiting the PMSC.

As a result, the project is behind schedule by 6 months:

- For Phase 1, work contracts are awarded and pending resettlement issues are being resolved through proper channels as agreed in the Grievance Redressing Mechanism, so that the contractors can mobilize on site and start construction.
- For Phase 2, it is unlikely that Phase 2 proceeds considering that a key (external) project to rehabilitate the solid waste landfill is not going ahead.

Financial Management:

Component 1: Financial management arrangements are in place but need to be improved by acquiring and implementing an automated accounting system. Once system is acquired, chart of accounts needs to be designed to capture and report on project transactions by component, sub-component and categories.

The PMU complies with the agreed financial management and audit arrangements. The last quarterly financial report 2020 Q3 was received and cleared by the Bank. 2020 Q4 interim report is due in February 2021. The Final Audit Report for 2020 is due by June 2021.

6. Status of the Grievance Redress Mechanism (GRM)

A three-tier GRM is being used. The bottom two tiers at the local and Ministry level, respectively, are operational. The third tier has just been established including representatives from various ministries, an independent lawyer and a civil society group representative. It has met once, to date, for training.

The GRM is active and includes 35 cases, of which 3 are outstanding with 2 being addressed to being in the process of closing and 1 going to the Appeal Committee with the PMU monitoring the outcome.

7. Results Monitoring

The project incurred delays due to COVID-19 lockdown and containment measures but also because of understaffed PMU with key positions still under recruitment including the project director, especially for the Quarterly Project Monitoring Report.



The result framework does not show much progress but all the Phase 1 work contracts have been awarded with some delays because of COVID-19 lockdown and full compliance with AIIB E&S policies, especially for resettlement.

Some of the policy actions are due in the final year of the project implementation and are reported as work in progress.
