2. Project Summary and Objectives

The Project aims to strengthen the national health system in Türkiye for COVID-19 response by upgrading designated pandemic hospitals in Istanbul and public hospitals across Türkiye through procurement of medical equipment. The total project cost is EUR 200 million and co-financed by EBRD (EUR 130 million) and AIIB (EUR 70 million).

The Project objective is to support the Government of Türkiye in strengthening its healthcare emergency response in public hospitals against the COVID-19 pandemic.

5. Project Implementation Update

The implementation of the project is underway, and all planned activities under Category 1 (medical equipment for public hospitals across Türkiye, such as ventilators, ICU monitors, CT Scanners, x-ray equipment, endoscopy equipment and other critical equipment) have been procured. Six of the nine packages of contracts are already closed, and the three remaining are awarded and expect to deliver the equipment before June 30, 2024. Approximately 71.5 % of the AIIB and EBRD's approved commitment for the co-financed component has been disbursed till date.An extension in the closing date was approved by both cofinanciers to allow for the equipment to be delivered. EBRD approved the extension on November 30, 2023, and AIIB on December 5, 2023. The Ministry of Health expects that all the remaining activities envisaged under the Project will be implemented and completed within the extended period (till June 30, 2024).
