### 2. Project Summary and Objectives

Objective: To prevent, detect, and respond to the threat posed by the COVID-19 pandemic and strengthen national systems for public health preparedness in Georgia.

The project has three components:

1) Emergency COVID-19 Response, including COVID-19 Case Detection and Confirmation, and Health System Strengthening for Case Management

2) Enabling health measures to contain the COVID-19 outbreak through temporary income support for poor households and vulnerable individuals through cash transfers and temporary unemployment assistance for individuals who lost their job because of COVID-19

3) Project Management and Monitoring



The project beneficiaries include the population at large given the nature of the disease, but importantly the infected people and at-risk populations, particularly the elderly and people with chronic conditions, medical and emergency personnel, medical and testing facilities, and public health agencies engaged in the response. In addition, the beneficiaries of social protection measures are the poor and vulnerable households, including those with informal workers as identified through the existing government administrative systems, formal private sector workers who were unemployed due to the lockdown or due to the restrictions adopted by the Government of Georgia to contain the spread of the COVID-19.

Project Cost is USD 180 million in Euro equivalent, being funded by the WB (USD 80 million) and AIIB (USD 100 million).

## 5. Project Implementation Update

The project provides support for the procurement of essential equipment and supplies, intensive care unit (ICU) equipment (e.g. ventilators, patient monitors, bronchoscopes), drugs, and medical supplies to strengthen the capacity of public health facilities designated for COVID-19. The project also provides support to public and private facilities that are designated to receive COVID-19 patients to compensate them for idle capacity and ensure standby readiness to provide COVID-19 care. In addition, the Project introduces mitigation measures in the form of financial support for poor and vulnerable households to enable them to comply with social distancing and COVID-19 containment measures and lockdown orders.

AllB's project loan was declared effective on June 17, 2020. Project implementation is currently underway.

Satisfactory progress has been made in the implementation activities till date. All three PDO indicators and nine out of ten intermediate indicators have already been achieved. The Project Operations Manual (POM) has been finalized and approved in October 2020, and further updated to reflect the changes in the legislation related to social benefits, and the additional financing for vaccines.

Over thirty five debt disbursements have taken place so far, and the overall disbursement level has crossed 97% of the approved loan amount.

For Component 1, the Project Implementation Unit (PIU) has signed several contracts for COVID-19 Diagnostic Kits, and they have been working with UNOPS to procure Personal Protective Equipment (PPE)

and critical medical equipment for key identified hospitals in Batumi, Kutaisi, Tbilisi, and Rukhi. Minor rehabilitation works of two regional medical facilities are in progress.

Implementation of Component 2 has successfully been completed with the final claim of reimbursement received in June 2021. This component has supported unemployed individuals, self-employed whose activity was affected by the crisis, as well as vulnerable and extremely poor households.

## E&S UPDATE in Q2-2023:

The ESMF has been completed as of November 2020 and properly disclosed. The PIU has staff in place, including one environmental (standards) specialist, one social (standards) specialist and one occupational health and safety specialist, in charge of implementing the requirements of the ESMF. The Stakeholders Engagement Plan (SEP) has been under implementation, including carrying out regular meetings with various project stakeholders. The Project Operations Manual (POM) adequately references the ESMF and includes the required safeguards for screening and management of potential impacts.

The Project Team conducted a joint project implementation supervision mission with the World Bank in May 2023. AIIB Project Team visited two project sites where rehabilitation work is ongoing. No ES related non-compliance was observed. The PIU has established a dedicated grievance mechanism to handle SEA/SH complaints and has also carried out a SEA/SH training for the representatives of health institutions involved in the project implementation.

Regarding sexual exploitation and abuse and sexual harassment (SEA/SH) prevention activities, with WB support, the PIU held a dedicated training for nominated SEA/SH grievance mechanism focal points in health institutions in October 2022. The PIU also reviewed the internal regulations of the project-participating institutions in the health sector and provided suggestions to include clear provisions on SEA/SH prevention and a Code of Conduct as part of the institutions' internal regulations. The PIU distributed leaflets and posters in health facilities aiming to raise awareness about SEA/SH issues and grievance mechanism. These trainings, coupled with WB-supported SEA/SH capacity building activities, represent an effort to enhance the overall capacity of the health institutions in Georgia to prevent and address SEA/SH issues.

## PROCUREMENT UPDATE in Q2-2023:

The procurement implementation is in compliance, and consistent with the agreed Procurement Plan. The Procurement Plan was updated in April 2023, and most of the procurement has been completed.

## Financial Management:

Q1 IUFR for FY23 was submitted on June 28, 2023. The project financial audit report (FY2022) is due on June 30, 2023. The PIU has been requested to ensure timely submission of reports.

In April 2023, based on a request from the Borrower, and in-line with the WB agreement, approval was obtained for:

a) Second extension of closing date till April 30, 2024, resulting in a cumulative extension of 24 months from the Original Closing Date

b) Reallocation of undisbursed amount between loan categories to enable full utilization of the committed amount by both co-financing institutions

Up to date, the PIU has not received any grievances directly associated with project activities. During the implementation of the Component 2, the social services agencies received a number of inquiries related to issues such as correction of data, bank account information, etc., and these were all addressed within the legally required time frame. The PIU has established a dedicated grievance mechanism to handle SEA/SH complaints. The project has not received any workers' grievances.

During the joint implementation supervision mission with WB in May 2023, as there have been no GRM cases received directly and reported by the PIU, AIIB and WB further enquired with the PIU on how the project GRM has been functioning and understood that: 1) There are different kinds of GRMs at each beneficiary institution, and since the local culture is to timely communicate with respective managers about the issues before escalation in writing, no formal registration of grievances has been finally observed at the PIU level. 2) There were some data collecting and reporting issues at the PIU level. Reminded and urged by both WB and AIIB, PIU has now proactively reached out to collect timely data and promised to further improve the information sharing as well as documentation of grievances received at beneficiary entity levels. AIIB and WB will continue to closely monitor the GRM and report if there are any complaints.

The Project commenced implementation in July 2020 after the PIU was set up.

In June 2021, IBRD has signed another Additional Financing (AF) Loan Agreement for this project, with an amount of EUR 28.7 million for vaccine financing. The original closing date of the parent project was April 30, 2022. Considering the time involved for deployment of vaccines, the closing date for the AF (and consequently for the parent project) has now been changed to April 30, 2023. Although AIIB did not participate in this additional financing, based on a request from the Ministry of Finance, the closing date for AIIB's loan was also extended by 12 months to April 30, 2023, to be in line with our co-financier.

Although the end targets in the results framework were determined with the Government in 2020, some of the targets which have already been achieved may be revised upwards, as the Government ramps up its efforts.

The most recent information regarding achievement of targeted results is listed below.

### Remarks:

The value of indicators reported refers to the use of funds covered by the project, which is jointly financed by IBRD (45% of the loan) and AIIB (55% of the loan).
