### 2. Project Summary and Objectives

The Project will strengthen national health system in Turkey for COVID-19 response by upgrading designated pandemic hospitals in Istanbul and public hospitals across Turkey through procurement of medical equipment. The total project cost is USD 236 million and co-financed by EBRD (USD 153.4 million) and AIIB (USD 82.6 million).

The Project objective is to support the Government of Turkey in strengthening its healthcare emergency response in public hospitals against the COVID-19 pandemic.

## 5. Project Implementation Update

The overall implementation has been delayed mainly due to COVID-19 surge from Dec 2020 until Oct 2021 (in the peak of 4th surge, about 30,000 confirmed cases per day) and subsequent lockdowns.

As of August 30, 2021, 8 packages have been awarded and signed as per the revised Procurement Plan. Due to the delay, the loan closing date may be extended



6 months, until June 30, 2022.
