Project Description	This project is proposed to be supported under AIIB's COVID-19 Crisis Recovery Facility and co-financed with the Asian Development Bank (ADB) for the procurement of vaccines eligible under ADB's Asia Pacific Vaccine Access Facility (APVAX) program. The project will provide critically needed vaccines to assist the Government of the Philippines in mitigating adverse health, social, and economic impacts caused by the COVID-19 pandemic.				
Objective	To support the Government of the Philippines for procurement of eligible COVID-19 vaccines.				
Expected Results (under review)	The expected impact of the project will be that the adverse effects of the COVID-19 pandemic on the population and the economy are mitigated through vaccination. The proposed expected results are: (1) number of people vaccinated; (2) disaggregation of the vaccinated population by age, gender, and priority group.

Environmental and Social Information	The loan is co-financed with and led by ADB.
