### 2. Project Summary and Objectives

The objective of the Project is to increase access to eligible COVID-19 vaccines for target population groups in Cambodia.

The Project will support the procurement of 14.5 million doses safe and effective vaccines against COVID-19. It will contribute to the government's goal of strengthening population immunity by providing booster doses and primary vaccination to children below 5 years of age. The Project is co-financed with the Asian Development Bank (ADB) under its rapid response component of ADB's Asia Pacific Vaccine Access Facility (APVAX).

The total Project cost is USD 153.5 million, for which AIIB finances USD50 million (32.57 percent), ADB finances USD95 million (61.89 percent) and the Government of Cambodia (GoC) finances the remaining USD8.5 million (5.54 percent). The loan proceeds from AIIB and ADB will finance expenditures relating to the procurement of COVID-19 vaccines that meet the APVAX eligibility criteria. The GoC contribution will cover financing charges, personnel

expenditure and vaccine storage and transportation expenses.

#### 5. Project Implementation Update

Through retroactive financing, a total amount of USD14.27 million (28.6% of loan amount) has been disbursed for those contracts awarded prior to the Loan Agreement signing. Given the evolution in the global Covid-19 pandemic situation, large scale procurement of booster doses for adult and of pediatric Covid-19 vaccines for children under the age 5 is not envisaged any more. The mission undertaken in March 2023 confirmed that the Government's intention to request project restructuring to incorporate Project Investment Component under ADB's APVAX. Based on the government's detailed proposal , ADB and AllB would consider the restructuring proposal.

#### Financial Management:

The Government of Cambodia established two advance accounts on 14 July 2022. The sub-accounts are yet to be opened. MEF will inform ADB and AIIB when the accounts have been opened. An annual audited project financial

statement (APFS) for FY2022 is due for submission on June 30, 2023 and subsequently throughout duration of the project. Since no disbursements were made in 2022, MOH may consider requesting ADB a deferment of the submission of the first APFS and consolidate APFS for FY2022 and FY2023 for submission in June 2024. The request to defer the first APFS and consolidated submission may be sent to ADB and AIIB by May 15, 2023. The audit will cover all areas of a standard audit (including audit opinion on the use of funds via retroactive financing) and will follow the MEF and Cambodian Public Sector Accounting Standards in terms of specific presentation of retroactive amounts in the financial statements. The government will present the status of the financial management action plan by the end of March 2023.

#### 6. Status of the Grievance Redress Mechanism (GRM)

GRM exists at the Government of Cambodia which is able to receive and address complaints.
