## 2. Project Summary and Objectives

The Project objectives are to improve access to reliable and resilient urban services and strengthen institutional capacities of urban service providers, and local governments in selected cities of the KP province. These objectives will be achieved through three interlinked outputs: (i) climate resilient and gender friendly urban infrastructure and services improved; (ii) institutional capacity and gender inclusiveness of urban service providers, provincial government, and city governments strengthened; and (iii) women's participation in urban governance and access to economic opportunities increased.

#### 5. Project Implementation Update

AIIB loan was made effective in May 2022, after which, key actions have been taken for smooth project start-up. Designated Accounts for loans' proceeds have been opened. Project Management Unit (PMU) has been established and a full time Project Director has been appointed in the PMU. Hiring of staff for City Implementation Units (CIU) established within each participating Water and Sanitation Services Company (WSSC) is in progress. The condition for withdrawal from loan and grant accounts has been satisfied. The project has made reasonable start after the loan effectiveness by exceeding the contract awards and disbursements target for CY23. A total of 13 contracts (totaling about USD234 million) have been awarded so far.

### Financial Management:

Partial Compliance of Financial Management Action Plan (FMAP) The project commenced the hiring of finance, accounts, and internal audit staff. However, the positions of (i) Director Finance, (ii) Accounts Officer – (Accounts) and (iii) One Accounts Assistant are still vacant. The Accounts Officer – Finance, has been given additional charge of Finance Director. The development standard operating procedures for finance and accounts related matters; and terms of reference of internal auditors have been completed, however the notifications have not been shared with ADB/AIIB. In addition, the project continues to use an Excel-based accounting system, as the accounting software is not yet deployed. Recommendations were made to address these matters and will be closely followed by ADB and AIIB Team. Audit Status The first Audited Project Financial Statements (APFS) for the period ended June 30, 2022, would have become due on December 31, 2022. However, considering that there were no disbursements until August 2022, a deferment of the first APFS was processed by ADB. Therefore, the APFS will be for the period ending June 30, 2023, covering from project effectiveness. The final report should be submitted to the ADB by December 31, 2023. In respect to the Audited Entity Financial Statements (AEFS) of the WSSCs, a general non-compliance is observed. The last available AEFS for four out of the five WSSCs is for the FY2020 – only Peshawar WSSC has the





AEFS for FY2021. It is understood that the delay is due to non-availability of Board members of the WSSCs. In the Inception Mission of ADB, it was proposed that the matter be escalated to the Secretary Local Government to ensure timely compliance and follow-up with the WSSCs. The mission agreed that all WSSCs shall seek a one-time extension for the submission of the audited financial statements, but all future AEFS would need to be submitted within the due date of December 31, of each year. Fiscal Transfer Policy of WSSCs The WSSCs expressed concern over the fiscal flow process since they are dependent on Tehsil Municipal Administration (TMAs) for their share which has proved a major bottleneck in financial discipline and planning at WSSC level. The Mission recommended that the GoKP prepare an Inter-Governmental Fiscal Transfer Policy and Strategy and Financial Management Plan and Guidelines for bringing financial efficiency and discipline in WSSCs.

### 6. Status of the Grievance Redress Mechanism (GRM)

The GRM is in place and Grievance Redress Committees (GRCs) have been notified in all five cities. Information regarding the GRM has been provided to the communities and in addition banners have been affixed at various places (especially at project sites where construction works have started) containing information regarding the GRM along with the contact information of the GRC focal persons. Complaints are being recorded and addressed as per the approved GRM procedures provided in LARP/CAP/RP and the status is being reported as part of internal monitoring reports.
