- 1. The Government of Andhra Pradesh through Government of India has received a loan from the Asian Infrastructure Investment Bank (AIIB) towards the cost of Andhra Pradesh Urban Water Supply and Septage Management Improvement Project (APUWS&SMIP). It is intended that part of the proceeds of this loan will be applied to eligible payments under the contract for providing Water Supply Improvement Scheme duly utilizing the executed stage wise component works in Municipal Towns of Nandigama & Tiruvuru in NTR District, Vuyyuru & Pedana in Krishna District and Addanki in Bapatla District under Superintending Engineer, Public Health Quality Control Circle, Guntur with Asian Infrastructure Investment Bank (AIIB) Funding.
- 2. The Superintending Engineer, Public Health Quality Control Circle, Guntur invites item rates tenders from the eligible tenderers in electronic procurement system for execution of Water Supply Improvement Schemes including completion of the balance stage component works under Source Package, Distribution Network Package including HSCs & Water Meters and Operation & Maintenance in Municipal towns of Nandigama & Tiruvuru in NTR District, Vuyyuru & Pedana in Krishna District and Addanki in Bapatla District consisting of the following main components in the following Municipal Towns under Superintending Engineer, Public Health Quality Control Circle, Guntur.
  - I. NTR DISTRICT
    - 1. Nandigama and 2. Tiruvuru
  - II. Krishna DISTRICT
    - 1. Vuyyuru and 2. Pedana

- Construction of Rapid gravity Water Treatment Plants
- Construction of Elevated Level Service Reservoirs
- Providing Electro Mechanical and erection of Dedicated feeders,

- 3. Tendering will be conducted through International Open Competitive Tendering (IOCT) as specified in the Bank's Procurement Instructions for Recipients (PIR) and is open to all eligible tenderers as defined in the PIR.
- 4. Tenders submitted manually will not be accepted. The tenderers would be required to register in the web-site. - 6. Tenders must be delivered to the address below [http://eprocure.gov.in/eprocure/app¹ on or before 13.10.2025 upto 17:00 Hrs (IST). Electronic tendering will be permitted. Late Tenders will be rejected.

Substitute the address for Tender submission if it is different from address for inquiry and issuance of the Tender Document.

Tenders will be opened in the presence of the participated tenderers' representatives who choose to attend at 11:00 Hrs (IST) on 16.10.2025 in the office of Superintending Engineer, Public Health Quality Control Circle, Guntur, Andhra Pradesh (India). If the office happens to be closed on the date of opening of the tenders as specified, the tenders will be opened on the next working day at the same time and venue.

7. For submitting tenders, the tenderers are required to have Digital Signature Certificate (DSC) issued from any of the authorized Certifying Authorities. Foreign tenderers from eligible countries may obtain Class-II DSC from the Certifying Authorities following the procedure described in the 'Downloads' option in the e-procurement portal <a href="https://eprocure.gov.in/eprocure/app">https://eprocure.gov.in/eprocure/app</a>.

## 8. Tender Security: INR 446.88 Lakhs

All Tenders must be accompanied by a tender security in the form as specified in the tendering document and shall have to be valid for 28 days beyond the validity of the tender.

- 9. The tenderers are also required to submit the following documents in the Office of the Superintending Engineer, Public Health Quality Control Circle, District Court Compound, Guntur, Pin code 522004, Andhra Pradesh (India) on or before the date and time of opening of Tenders either by registered post / courier or by hand, failing which the tenders shall be declared non-responsive. The department will not take any responsibility for Postal / Courier delays.
  - (a) Original tender security in approved form and
  - (b) **Original power of Attorney** authorizing the person to sign the tenders on behalf of the tenderer as per Clause 20 of ITT of tender documents
  - i) The above documents may be submitted in one envelope. The tenderers shall not write their names or addresses on this envelope.
  - ii) The number mentioned on acknowledgement of online submission of the tender by the tenderer shall be mentioned on envelope containing the documents as detailed above.
- 10. Pre-tender meeting will be held on **19.09.2025 at 11:00 Hrs (IST)** in the office of **Engineer-in-Chief (PH)**, **Tadepalli**, **Guntur District**, **Andhra Pradesh** to clarify the issues and to answer questions on any matter that may be raised at that stage as stated in Clause 7.4 of 'Instructions to Tenderers' of the tendering document.
- 11. There is no margin of preference to the domestic tenderers.
