The Water and Sanitation Agency, Lahore, Pakistan ("the Employer") invites sealed Tenders (Single-Stage, Two-Envelopes) from eligible Tenderers for the execution of the "Lahore Wastewater and Drainage Management Project (LWDMP) Sewerage System from Larechs Colony to Gulshan-e-Ravi Lahore (Through Trenchless Technology)" ("the Works") on EPC/Turnkey basis.     - a. Line A: LARECHs Colony to Qartaba Chowk, Lahore (incl. pipe dia of 1050-, 1500- & 2400-mm). Length = 12.14 km.
    - b. Line B: Gurumangat to Qartaba Chowk, Lahore (incl. pipe dia of 1050-, 1500-& 2400-mm). Length = 12.82 km.
    - c. Line C: Qartaba Chowk to Gulshan-e-Ravi, Lahore (incl. pipe dia of 1050-, & 3500-mm). Length = 7.25 km.
  - Laying of Lateral Sewers (450 mm) = 159 m
  - Total Route Length = 32.37 km
  - Design Horizon and Design Discharge = 2050 and 688 Cusecs respectively
  - Construction of Ultimate Disposal Station of Discharge Capacity 848 cusecs including SCADA at Gulshan e Ravi Disposal Station.
  - Rehabilitation of existing drains and Outfall channel (8 km approx.)
  - Laying of Rider Sewers (300-, 600-mm) = 8.48 km approx.
