1. **Islamic Republic of Pakistan** has received financing from the **Asian Infrastructure Investment Bank (AIIB)** toward the cost of the **PPSF Financed Procurement to Support the Preparation of the Proposed AIIB-Financed Reconstruction of National Highway N-5 under Pakistan’s Resilient Recovery, Rehabilitation and Reconstruction Framework Project** and intends to apply part of the proceeds for the consulting services for which this REOI is issued.
2. The consulting services (“the Services”) include the Development of a Digital Project Management Platform for the N-5 highway project leveraging Geographical Information System (GIS) and Building Information Modeling (BIM) technologies. The consultant will work with the NHA as per agreement to carry out the tasks outlined in the TOR.
3. The detailed Terms of Reference (TOR) for the assignment are attached to this Request for Expressions of Interest.
4. The National Highway Authority now invites eligible consulting firms (“Consultants”) to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The shortlisting criteria are:  
Consultants Qualifications: The following requirements are a broad description of the likely expertise needed for this consultancy assignment. The Consultant shall:
  - (i) be a firm with international experience (preferably an international firm) with appropriate and sufficient capabilities, resources, and experience to execute the full extent of the scope of services to very high quality. A firm with international experience may act as lead partner or main consultant to associate with other firm(s) in form of Joint Venture, or main / sub consultant in order to enhance its qualifications, local support, field activities, etc.
  - (ii) have demonstrated experience in
    - (a) Software/ databases / web interface development for mega projects
    - (b) development of digital project monitoring platform using BIM and GIS,

- (c) digital monitoring of road construction/rehabilitation / improvement projects
  - (d) utilization of satellite technology / aerial imaging for project monitoring
  - (iii) have a proven record of completing similar assignments successfully. The experience of projects funded through IFIs shall be preferred.

5. The attention of interested Consultants is drawn to Section II of the Bank's Procurement Instructions for Recipients (PIR) dated July 2024, setting forth the Bank's policy on conflict of interest.
  6. Consultants may associate with other firms to enhance their qualifications, but should indicate clearly whether the association is in the form of a joint venture and/or a sub-consultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.
  7. A Consultant will be selected in accordance with the ***Quality and Cost Based Selection (QCBS)*** method set out in the PIR dated July 2024.

  9. Expressions of interest must be delivered in a written form to the address below (in person, or by mail.) before **29<sup>th</sup> June, 2026 at 11:00 Hours (PST) and opening shall be the same date immediately after closing.**
  10. All the EOI submissions received after the procurement process advertised earlier on 15<sup>th</sup> November 2025 have been rejected and the process has been relaunched by this "Request for Expressions of Interest".
