The Republic of Uzbekistan has received financing from the Asian Infrastructure Investment Bank (AIIB or the Bank) toward the cost of the **Bukhara Region Water Supply and Sewerage Project (Phase 1)** and intends to apply part of the proceeds toward payments under the contract for **Construction and Reconstruction Works for Water Supply and Distribution in Kagan District of Bukhara Region**. The tendering process will be governed by the Bank's Procurement Instructions for Recipients (PIR) dated July 2024.
2. The AIIB PCU under JSC Uzsvtaminot now invites sealed tenders from eligible Tenderers for Construction and Reconstruction Works for Water Supply and Distribution in Kagan District of Bukhara Region. The works include mainly the following:
