The Republic of Uzbekistan intends to apply for financing from the Asian Infrastructure Investment Bank (AIIB) toward the cost of *Karakalpakstan and Khorezm Local Roads Network Reconstruction Project*, and intends to apply part of the proceeds toward payments under the contracts for *KKLRNP/CW/01*.
2. The Agency "Avtoylinvest" now invites sealed Tenders from eligible Tenderers from eligible and qualified bidders for the Contract No. KKLRNP-CW-01, for Reconstruction of 188 km local roads in Khorezm region: Lot 2: Reconstruction of 56 km local roads in Khiva and Koshkopir regions; Lot 3: Reconstruction of 74 km local roads in Urgench, Shavat and Gurlan regions. For each Lot the duration of the contract will be 5 years, out of which the construction period is 1095 days, the Defects Notification Period is 730 days. The key qualification criteria for Tenderers are given below and are further elaborated in Section III of the bidding document whereby in case Tenderer bids for several Lots, the requirements of each Lot will be summed up.

4. Tendering will be conducted through International Open Competitive Tendering procedures as specified in the Bank's Procurement Instructions for Recipients (PIR), and is open to all eligible Tenderers as defined in the PIR.
